About Westminster Abbey

Above all else, the Abbey is a living church, a place of prayer and praise and holy ground at the heart of the nation. It is also a treasured part of Britain's heritage and a leading venue for tourism. The Abbey has occupied a central place in the celebration of great events for the nation and remains one of the most beautiful architectural masterpieces in Britain.

Westminster Abbey is where the coronation of Kings and Queens has taken place since 1066, and where many of the Kings and Queens of England and of the United Kingdom are buried. Principal among them is St Edward the Confessor, King of England from 1042 to 1066, whose shrine is at the heart of the Abbey Church. Beside and around them are buried or commemorated many of the great women and men from almost every century of British history: statesmen and politicians, lawyers, warriors, clerics, writers, musicians and artists.

Neither a cathedral nor a parish church, Westminster Abbey (or the Collegiate Church of St Peter in Westminster, to give it its correct title) is a Royal Peculiar under the jurisdiction of a Dean and Chapter, and with direct accountability to the Sovereign. This relationship with the Sovereign dates back to the origins of the Abbey over a millennium ago, but its current form stems from the Charter granted to the Abbey by Elizabeth I on 21st May 1560.

The Dean is the Abbey's head of house and Ordinary. The four Canons of Westminster and the Dean comprise the Dean & Chapter, the governing body of the Collegiate Church of St Peter in Westminster, commonly known as Westminster Abbey. The Dean and Canons are also members of the Strategic Board of the Abbey. They are supported by the Receiver General and Chapter Clerk, who is head of the lay administration of the Abbey.

The Dean & Chapter forms the core of the Collegiate body, which includes the High Steward and High Bailiff of Westminster (currently the Duke of Buccleuch and Sir Ken Olisa) and their deputies, the Minor Canons, certain senior lay members of the Abbey staff, key advisors, senior staff of Westminster School and the Harris Federation, the Lay Vicars, the choristers and the forty-eight King's Scholars of Westminster School.

We are a welcoming community, though also complex and multi-faceted, with around 600 highly committed clergy, employees and volunteers. We have deep respect for the heritage of which we are the custodians, whilst we evolve continuously to meet the opportunities of the future. In recent times, this has included the creation of new departments to focus on transforming our digital presence and delivering a significantly expanded programme of public and community engagement. In addition, our newly created Employee Engagement Forum and Social Engagement programme are helping us to support and develop our staff and volunteers.

The Dean and Chapter of Westminster defines our Mission in these terms:

- To offer daily divine Worship to Almighty God and resource the Church in this vocation;
- To serve the Sovereign;
- To proclaim the Gospel to the nation and Commonwealth, celebrating the distinctive witness of the Christian faith and engaging with the public square;
- To provide a safe, welcoming and inspiring environment for all who come to the Abbey;
- To care for the precious resources entrusted to us: our people, partnerships, buildings, heritage and money.

Following the State Funeral of Queen Elizabeth II and the Coronation of King Charles III and Queen Camilla, which were broadcast to national and international audiences in their millions, interest in the Abbey is very strong. We attract over a million visitors from around the world every year, and our summers and peak period are incredibly busy. However, we receive no regular income from the State, the Church of England or the Crown, and rely almost entirely on income from visitors.

Introduction and Profile

Thank you for your interest in the Commonwealth Theologian in Residence Scholarship, an opportunity for an exceptional scholar from a Commonwealth country to spend one term living within the Westminster Abbey precincts, with opportunities for study, preaching, and seminars. The inaugural holder of this post was The Revd Dr Ishaya Anthony, Canon Theologian of the Diocese of Kwoi, Nigeria, and postdoctoral Research Fellow at the Department of Religious Studies, University of Johannesburg.

Westminster Abbey offers this opportunity as a further development of its long-standing commitment to the Commonwealth and to theological scholarship in the life of the Church. The successful candidate will pursue research or a writing project of their choice. The time may be used as part of a sabbatical. It is hoped that the successful candidate might play some part in the annual Commonwealth Day Service, held each year on the second Monday in March.

To qualify, you will need to have completed doctoral study, and/or have a track record of exceptional research or teaching. We seek theological dialogue partners with strong communication and interpersonal skills, committed to open conversation and serious reflection. The opportunity is open to scholars working in any theological discipline who have a passion for the life of the Church. There will also be opportunities to build connections and partnerships with the ecclesial and theological institutions associated with Westminster Abbey.

The successful applicant should be prepared to participate in the daily worshipping life of the Abbey in ways which are appropriate, especially on Sundays.

The closing date for applications is 11th September 2025, and the online selection process will take place on 23rd September 2025.

Grant requirements

Essential

Personal Character:

- A resident or national of a Commonwealth country.
- If not an Anglican, then a communicant member of another Trinitarian church which is a member or affiliate of the World Council of Churches.

Education:

- Experience of significant postgraduate study or research.

Skills/Aptitudes:

- Proven expertise in their chosen academic discipline.
- Excellent skills in written and oral communication.
- Enthusiasm about the role of theology in the life of the Church.

Knowledge/Experience:

- Experience of ecumenical and/or interfaith working

Desirable

Knowledge/Experience:

- A teaching staff member of an academic faculty or theological college.
- A track record of exceptional research and/or teaching.

Personal Character:

- An ordained or lay minister in a Church of the Anglican Communion, a Church in communion therewith, or otherwise of another Trinitarian Church.

Terms

Allowance

There will be an allowance of £4,500 for one term (three months).

This will be paid in three equal instalments.

Payment will be made via bank transfer to a UK bank account.

Duration

This opportunity is for the duration of the Lent Term (early January 2026 until Easter Week).

Accommodation

Accommodation will be provided rent-free.

The Dean & Chapter will meet all charges in respect of Council Tax and utilities (excluding private telephone charges).

Reasonable Travel costs

The Abbey will reimburse all reasonable travel costs, upon receiving satisfactory receipts.

These can include one set of economy return flights, airport transfers, taxis, and other reasonable modes of transportation.

Discounts

You will receive a 20% discount on purchases from the Westminster Abbey shop and a 30% discount on purchases from the Benugo outlets, which serve refreshments.

You will be able to obtain wristbands, which allow free visits for family and friends to visit the Abbey.

Clear information on how you meet all aspects of the Person Specification, with relevant examples, will help us with shortlisting.

Applications should arrive no later than 11th September 2025. Interviews are scheduled to take place on 23rd September 2025.
